Meeting called to order at 7:00 pm by Marty Milanowski, Chairperson. Pledge of Allegiance recited.

Marty Milanowski stated that the town is having a public hearing to vote on the rezoning of tax parcels 15549 and 35277. He disclosed to the public that the parcels now fall under the tax id 37391. He asked the public if anyone else wanted to sign up to speak because if they did this evening, they were to sign in on a sheet provided at the door. Marty then gave a general overview of what Northern Clearing is looking to do with the parcels. A few residents began speaking so Marty stated they would get started right away on comments from anyone who signed up to speak.

Scottie Sandstrom Spoke in favor of Northern Clearing and what they will bring to the Town of Eileen.

Nicholas Suminski, who is not a resident of the town, spoke against the rezoning of the two parcels as he will be inheriting the parcels eventually.

**Josh Rowley** from Bayfield County Zoning stated that Ag land is not only available for farming and that this can be found online to review the uses of land that is zoned agriculturally. Nicholas Suminski questioned that if the town does zone to commercial, does that mean there is no say over the land use? Josh confirmed that is correct.

**Brad Gustafson** who works for Northern Clearing, stated that they did not want to take up all of the business park use and that the areas they chose to build were safer for their trucks. He stated they have been denied access from US2 by the State of Wisconsin. He stated as well regarding concerns of run-off that there is a 99% chance they will have to put in a retention pond.

Bryan Custer stated that he was making it clear that they just chose not to go into the business park.

Marty Milanowski asked if anyone had anything further to question or say. No one did.

Skip Radosevich made a motion to adjourn the public hearing meeting, seconded by Tony Johanik. Motion carried. Meeting adjourned at 8:41 PM. Marty stated they would take a short break so residents could move around for a few minutes.
